



Recommended Controls for COVID-19 Risk Assessment V12 Aug 2021

The expectation is that our schools should be operating as close to normal as possible. Pupils and staff should only be out of school where clinically advised by NHS Test and Trace, i.e.

- have received a positive covid test within the last 10 days, or
- are displaying symptoms and waiting for PCR test results, or
- have been identified as a close contact, are over 18 years and 6 months and not fully vaccinated for reasons other than medical.

Schools will take with particular care in following the redefined system of controls communicated by the DfE.

1. Ensure good hygiene for everyone.
2. Maintain appropriate cleaning regimes.
3. Keep occupied spaces well ventilated.
4. Follow public health advice on testing, self-isolation and managing confirmed cases of COVID-19.

The Governing Body/Trust Board must take ownership of the risk assessment and have an oversight of the principles behind its contents. It is based on the core operational guidance for schools found at

Schools should review and update their wider premises, staff and pupil risk assessments considering the need for relevant revised controls in respect of their conventional risk profile taking into account the implications of COVID-19. Schools should have an Outbreak Management Plan in place outlining how they would operate if there was an outbreak in their school or in the local area.

The following school policies (but not limited to) will also be reviewed and updated as required:

Behaviour Policy, Safeguarding and Child Protection Policy, Health and Safety Policy, Infection Control Policy, First Aid Policy, School Emergency Plan, School Business Continuity Plan, Premises Lettings, Policy and Contract.

<p>Asymptomatic Transmission: Promote & Engage in asymptomatic Testing where available</p> <p>On site testing</p> <p>Home Testing</p>	<ul style="list-style-type: none"> • Staff and secondary pupils should continue to test regularly from the start of term • Secondary schools should retain a small asymptomatic testing site (ATS) on-site until further notice so they can offer testing to pupils who are unable to test themselves at home • All secondary school pupils should receive 2 lateral flow device tests, 3 to 5 days apart, on their return in the autumn term. Positive tests will be reported via the school and pupils will be sent home to isolate until a confirmatory PCR test has been carried out to confirm. • Pupils should then continue to test twice weekly at home until the end of September, when the scheme will be reviewed. • Staff should undertake twice weekly home tests whenever they are on site until the end of September, when this will also be reviewed. • Testing is not mandatory although participation in testing is strongly encouraged. • Test subjects must report their result to NHS Test and Trace as soon as the test is completed either online or by telephone as per the instructions in the home test kit. • Anyone with a positive LFD test result will need to self-isolate in line with the stay at home guidance and arrange a polymerase chain reaction (PCR) test, isolating until the PCR result is known. • Anyone with a subsequent negative PCR test result within 2 days of the positive LFD can continue to attend school provided they have no covid symptoms. • Pupils not undergoing testing should attend school in line with return arrangements. <p>Schools are no longer expected to fulfil contact tracing duties; close contacts will now be identified and contacted by NHS Test and Trace.</p>	<p>All staff and students</p> <p>All staff and students</p> <p>All staff and students</p> <p>Parents in conjunction with track and trace</p>	<p>Beginning of term</p> <p>Ongoing</p> <p>Ongoing</p>

<p>Close contact Tracing & PCR testing</p>	<ul style="list-style-type: none"> • Individuals identified as close contacts are not required to self-isolate if they live in the same household as someone with COVID-19, or are a close contact of someone with COVID-19, and any of the following apply: <ul style="list-style-type: none"> ○ they are fully vaccinated ○ they are below the age of 18 years and 6 months ○ they have taken part in or are currently part of an approved COVID-19 vaccine trial ○ they are not able to get vaccinated for medical reasons • Close contacts contacted by NHS Test and Trace will be advised to take a <u>PCR test</u>. If this is positive, their 10 day isolation begins from the test date. • Staff who do not need to isolate, and children and young people aged under 18 years 6 months who usually attend school, and have been identified as a close contact, should continue to attend school as normal. <ul style="list-style-type: none"> ○ They do not need to wear a face covering within the school, but it is expected and recommended that these are worn when travelling on public or dedicated transport. • 18-year-olds will be treated in the same way as children until 6 months after their 18th birthday, to allow them the opportunity to get fully vaccinated. <p>Symptomatic Transmission: Minimising contact with individuals who are unwell with COVID-19 symptoms</p>	<ul style="list-style-type: none"> • Staff or pupils should not come into the school if they have coronavirus (COVID-19) symptoms, they should seek a PCR test asap. • Anyone who has tested positive, confirmed with a PCR test, within in the last 10 days should isolate in line with guidance. <ul style="list-style-type: none"> ○ Remote learning provision may be available for those pupils well enough to learn in isolation if required. 	<ul style="list-style-type: none"> • Everyone will wash their hands thoroughly for 20 seconds with soap and running water or use hand sanitiser after any contact with someone who is unwell. See the COVID-19: cleaning of non-healthcare settings guidance. • In an emergency, call 999 if someone is seriously ill or injured or their life is at risk. First aid can be administered however, strict hygiene measures (hand washing etc.) should be carried out as soon as possible after. • Any medication given to ease the unwell individual's symptoms, e.g. paracetamol, is administered in accordance with the school's policy. • Members of staff displaying symptoms of COVID-19 will report to LT and follow advice given. • If a member of staff or child subsequently receives a positive test result for COVID 19, they should inform the school office as soon as possible. • If the staff member or pupil test negative and no longer have symptoms similar to coronavirus (COVID-19), they can stop self-isolating and return to school. In normal circumstances, no proof of negative test is needed. • In the event that school and parents disagree that a child may be suffering from COVID-19, school can refuse to allow a child to attend until a negative test has been provided in order to protect other pupils and staff from possible infection. <p>Increased level of community transmission: Response to increased levels of infection</p>	<ul style="list-style-type: none"> • School will seek public health advice and consider invoking the contingency framework on reaching the lower threshold of: <ul style="list-style-type: none"> ○ 5 pupils or staff, who are likely to have mixed closely, test positive for COVID-19 within a 10-day period; or ○ 10% of pupils or staff who are likely to have mixed closely test positive for COVID-19 within a 10-day period • The definition of a group that is likely to have mixed closely is <ul style="list-style-type: none"> ○ form group or subject class ○ friendship group mixing at breaktimes ○ sports team ○ group in an after-school activity • School will communicate with parents in the event of the contingency framework being activated 	LT	

<p>On site transmission: Preventative Hygiene Practices</p>	<p>The COVID-19: cleaning of non-healthcare settings guidance is followed;</p> <ul style="list-style-type: none"> • https://www.gov.uk/government/publications/covid-19-decontamination-in-non-healthcare-settings/covid-19-decontamination-in-non-healthcare-settings • Minimise contact with individuals who are unwell • Sufficient handwashing facilities are available. Where a sink is not nearby, provide hand sanitisers in classrooms and other learning environments. Coronavirus (COVID-19) is an easy virus to remove when it is on skin. Airborne Transmission: Ventilation	<p>Ventilation reduces the concentration of the virus in the air which reduces the risk from airborne transmission. Occupied spaces should be well ventilated and a comfortable environment is maintained by using the following measures:</p> <ul style="list-style-type: none"> Systems should be well maintained in accordance with the manufacturer's recommendations Fresh air is essential at all times in classrooms, open windows for natural ventilation. Windows should be opened enough to provide constant background ventilation and opened more fully during breaks to purge the air in the space Opening external doors may also be appropriate (as long as they are not fire doors and where safe to do so) School will be supplied with CO2 monitors in Sept, further guidance on use and actions will be provided in due course 	All staff	Ongoing
Close contact transmission: Face Coverings	<p>Face coverings are no longer be advised for pupils, staff and visitors either in the classrooms or communal areas.</p> <p>Government recommendation is face coverings are worn in enclosed and crowded spaces where you may come into contact with people you don't normally meet. <p>Close contact transmission: PPE</p>	<p>Face coverings are not classified as PPE (personal protective equipment)</p> <ul style="list-style-type: none"> • Most staff will not require PPE beyond what they would normally need for their work. • If a pupil already has a routine intimate care needs that involve the use of PPE, the same PPE should continue to be used. • PPE for COVID scenarios is only required when: <ul style="list-style-type: none"> ○ A pupil becomes ill with COVID-19 symptoms, and only then if a 2 metre distance cannot be maintained ○ Performing aerosol generating procedures (AGP's) • Children and young people who cough, spit or vomit but do not have COVID-19 symptoms, any PPE that would be routinely worn, should be worn 	<p>LT to communicate where necessary</p>	
<p>Negative educational impact: Attendance & recording attendance</p>	<p>School attendance is mandatory for all pupils and the usual rules on school attendance will apply, including:</p> <ul style="list-style-type: none"> • Parents' duty to secure their child's regular attendance at school (where the child is a registered pupil at the school and they are of compulsory school age) • In the context of the pandemic and coronavirus vaccination programme, if evidence of persistent absence is required, it can take the form of prescriptions, appointment cards, text or email confirmation of appointments, etc. rather than a doctors' note. • Remote education should only be provided to pupils who are unable to attend because they are complying with isolation guidance around coronavirus (COVID-19) – i.e. they have registered a positive test and are following the stay at home guidance but are well enough to attend lessons remotely. 	<p>Parental responsibility</p>	<p>Ongoing</p>

Increased risk due to vulnerability: Staff who are pregnant	<ul style="list-style-type: none"> • Pregnant staff were considered in the ‘clinically vulnerable’ category. The school and the individual will follow the advice in the coronavirus (COVID-19) advice for pregnant employees and refer to the school risk assessment for pregnant women. • Increase hand washing and cleaning of frequently touched areas in the workplace and follow the “System of Control” measures. • Joint Committee for Vaccination and Immunisation (JCVI) has announced it will be offering pregnant women the COVID-19 vaccine, in line with the vaccine roll out plan for the UK. Community transmission: Managing school transport	<ul style="list-style-type: none"> • Parents, children and young people are encouraged to walk or cycle to their education setting where possible; • Parents and pupils are discouraged from using public transport, where possible particularly during peak times. If public transport is used then a face covering must be worn at all times. • Transport arrangements are organised to cater for any changes to start and finish times • Transport providers are advised that they do not work if they or a member of their household are displaying any symptoms of coronavirus (if applicable) • Transport providers, as far as possible, are advised of the need to follow hygiene rules and try to keep distance from their passengers (if applicable) 	Admin & LT	Ongoing
